It is with honour that I am applying to be a councillor for the Township of Billings.

My skills include Information Manager AS5--civilian equivalent, crisis management team lead, executive base management team lead-including housing requirements manager--and CanEx market steward coordinator. I have directed groups of people responsible for the construction and maintenance of facilities to include Canadian Airforce Museums and recreational facilities. I enjoyed my time as a volunteer soccer coach for youths (5 yr-15yrs). I oversaw emergency fire, medical and police response units, as well. During my 20 years of employment with the Canadian Armed Forces, I managed both public and non-public funds for 22 Wing North Bay: with a small budget of 70K. I am an exceptional public speaker, I have received awards and accolades during my time with non-profit organizations such as, the Canadian and American Diabetes associations. As the regional manager for the Northeast Ontario CDA and Colorado Springs, Colorado ADA I was invited to speak on behalf of both organizations in efforts to educate and fundraise. As an executive assistant to the 22 Wing Base Commander, I oversaw and aided in the health and welfare of approximately 450 service members and their families. In that role I would host and conducted fund raising activities such as winter carnivals and support for a variety of charities, such as the Canadian Cancer Society. I have taken middle management courses and courses in basic firefighting and

multiple emergency response and crisis management; for my community. I was a team lead for a Military Tattoo performance in North Bay, which I have also organized. This performance required coordination between my office, as the Assistant to the base Commander, and the then Mayor, Victor Fideli. The Military tattoo saw bands and performers from all over Canada descend upon the township in need of food and lodging. This event raised tens of thousands of dollars for the local community. I have been involved with the security and organization of Heritage Days in Northern Ontario communities. I am also familiar with applying for funding through programs, such as the Northern Ontario Heritage fund, to help enhance the communities where I have lived. I would enjoy using my skill set to promote Billings Township in Northern Ontario, as a business friendly and family-oriented community.

Please accept this letter as my application for the vacant Billings Council position. By way of background, I was born and raised in the suburbs of Vancouver, BC and joined the Royal Canadian Air Force right after high school. After obtaining my engineering degree, I flew helicopters in support of the Army. I flew across Canada, in the USA and did one peacekeeping tour in the Sinai Peninsula stationed approximately 10 km from the Gaza Strip. In 2005, I left the military and my son and I moved north to follow my wife's career. Upon leaving the military, I started a consulting business and in 2007, I joined the LaCloche Manitoulin Business Assistance Corporation (LAMBAC) as their Community Economic Development Officer. I left LAMBAC and my consulting business in 2014, and took on the role as a wind farm manager for General Electric (GE) first for just one wind farm in Little Current and then after a few years, I became the manager for two additional wind farms: one in Nova Scotia and the other in Massachusetts. I left GE in 2022 and restarted my consulting business and since then have helped a not-forprofit organization with a public transportation project and a for-profit company with a sales project. As previously indicated, I am married. We have one child, a son, who lives in Ottawa with his wife. My wife and I enjoy living in Kagawong and on the Island. We enjoy walking the trails and roads with our dog and we really enjoy boating in the North Channel. We are big fans of the new marina!

In terms of why I want the position as Billings Councillor, the reason is that I want to represent the community and be part of the decision-making body that leads our township not only with resolving present day-to-day issues but also laying the groundwork for a successful community in the future. I want to help the community maintain and hopefully grow its status as one of the premiere places to live and work on Manitoulin Island.

There are likely other people in the Township who are similarly motivated to me so let me touch on my qualifications which I believe will set me apart from other candidates. To be an effective Billings Councillor, one should have a broad range of experiences and also, one must have the time to dedicate to the position. I believe experience is necessary because more experience generally should enable a councillor to better understand and resolve issues. Time is necessary because, no matter how passionate and keen one is to serve the community, without having the time to dedicate to doing the work, a councillor simply cannot be effective.

In terms of experience, first, let's start with the fact that I have lived in Kagawong for almost 20 years. While I will never be a Haweater, I can say that I have good amount of knowledge of Billings Township and the Island. Knowledge of the local area will assist me, as a councillor, in dealing with Billings' specific issues and in dealing with pan-Island issues that Billings Council may wish to become involved in. My work experience is also an asset. Whether I was dealing with flying operations, helping a local abattoir get up and running, assisting a local business with improving their sales or bringing green energy to the Island, I have been able to see issues clearly, bring solutions to the fore, and once a decision is made whether by me or others, implement decisions to achieve success. I expect to use these same skills as a councillor to provide thoughtful comment and where necessary, make sound decisions. All work experience is valuable but by far, my work at LAMBAC is my greatest asset to being an effective councillor. As the Community Economic Development officer, I worked with many municipalities and not for profit organizations on the Island and the North Shore. Indeed, one of my last projects with LAMBAC was working with former Billings Mayor Aus Hunt and former Councillor Tom Imrie on a Billings committee to develop ideas for waterfront development. In general, I have the necessary work and life experience to become an effective councillor for Billings Township.

The second necessary qualification to being an effective councillor is to have the time to dedicate to the position. While at LAMBAC, I worked with many councillors. It was obvious to me when sitting in a committee meeting with local councillors who was prepared for the meeting and who was not. I understand that there is more to being a councillor than just voting at council meetings. There can be a significant amount of preparation necessary to be informed on an issue before it even comes to council chambers. I will be that councillor who is prepared. Now that I have effectively retired, I have the time available to prepare for and participate fully in council activities.

In closing, I would like to thank you for your time and for your consideration of my application for the vacant Billings Council position. While I have not been a councillor before, I believe I have the necessary life and work experiences to be an effective councillor. Should I be fortunate enough to be selected to fill the position, I will dedicate the necessary time and effort to ensure I am fully prepared and ready for the work involved.

BY-LAW NO 2024-08

BEING A BY-LAW TO CONFIRM THE PROCEEDINGS OF THE COUNCIL OF THE TOWNSHIP OF BILLINGS

WHEREAS the Municipal Act S.O. 2001, c 25, Section 5(1), as amended, provides that the powers of a municipal corporation are to be exercised by its Council;

AND WHEREAS the Municipal Act S.O. 2001, c 25, Section 5(3), as amended, provides that a municipal power, including a municipality's capacity rights, powers and privileges under Section 9; shall be exercised by By-Law;

AND WHEREAS The Council for The Corporation of the Township of Billings deems it expedient that the proceedings of meetings of the Council be confirmed and adopted by By-Law;

NOW THEREFORE the Council of The Corporation of the Township of Billings enacts as follows:

- 1. THAT the actions of the Council of The Corporation of The Township of Billings at its Council Meeting held on February 6, 2024 in respect to each report, motion, resolution, or other actions recorded and taken by Council at its meetings, except where the prior approval of the Ontario Lands Tribunal is required is hereby adopted, ratified, and confirmed as if all such proceedings were expressly embodied in this By-Law.
- 2. THAT the Mayor and CAO/Clerk, or such other official as deem appropriate are hereby authorized and directed to do all things necessary to give effect to the said action, of Council of the Township of Billings referred to in the proceeding section.
- 3. THAT the Mayor and CAO/Clerk are hereby authorized and directed to execute all documents necessary on behalf of the Council and to affix the corporate seal of The Corporation of The Township of Billings to all such documents.
- 4. THIS By-Law shall come into full force and effect upon final passage.
- 5. THIS By-Law may be cited as the "February 6, 2024 Confirmatory By-Law".
